Advocacy as an Ally/Family Member--Lauri Cole NYS Council for Community Behavioral Healthcare 1:45 pm Executive Director of the NYS Council for Community Behavioral Healthcare, Lauri Cole spoke about her experience as an advocate for members of the mental health and substance use disorder communities from the unique perspective of being both a family member and survivor who lost her loved one from addiction, and how she is using her experience to effectively advocate for members of the recovery community in a meaningful way.

NYS Council for Community Behavioral Healthcare now represents 100 mental health and behavioral health organizations throughout the state; The organizations each pay membership dues. The mission of the organization is access to care and continuity of care;

Lauri and her team are working day and night to ensure the opioid proposal passes because it is the best option right now for a consistent flowing stream of revenue given the current crisis. The Senate did not embrace vehicle for future money. Say to Senate—if you cannot live with the Surcharge you need to enact a permanent funding stream.

What happened to the Asset Forfeiture Fund: supposed to be permanent source of revenue for OASAS? Without overt language that designates money to OASAS, money may have found its way to General Fund.

Lauri and her team work on a federal level as well, working with Congressman Paul Tonko. There are hearings in Washington on Opioid package of bills; Lauri's organization worked on a sign on letter to end a arbitrary caps on prescribers for Medication Assisted Treatment; appropriately educated prescribers should be able to prescribe more than at the caps until further notice.

## Parity @ 10 Campaign – Karla Lopez, Legal Action Center

Senior Staff Attorney of Legal Action Center spoke about the Parity @ 10 campaign, new tools that have been developed to help individuals and families navigate the insurance industry and how parity enforcement is essential right to the Recovery Community. The Parity @ 10 Campaign aims for effective enforcement of the Mental Health Parity and Addiction Equity Act (Parity Act). Q&A to follow.

See powerpoint attached with links to educational posters as well as contact information when one feels that parity is not being followed. Karla emphasized the need to complain. Government officals think "We don't get complaints so there are no problems." NYS Attorney General has settled complaints; they have healthcare phone line 1-800-428-9071. In complaint write "I want you to check if there are any violations to the parity law."

Parity @ 10 wants regulators to provide proof of parity (on front end) so it does not fall on back end patients and providers. Parity @ 10 also asks for a Parity Ombudsman—idea is to have specialized place people can go when they need help accessing MHSA benefits. Legla Action Center also has a comprehensive parity guide.

Karla asked the group: What barriers are you seeing?

- Difference reimbursement rates;
- Pain versus addiction
- Copays for every visit for MHSA—some people have to come twice in one day—not the same for chemo therapy—pay a copay for a package

Would like to see If denied by hospital—get letter that says why they are denied and where they can go Senator Ort's Bill—S1156/A.3694 requiring insurers and health plans to submit data and key metrics on compliance with parity laws

The State should educate people with their resources; Parity @ 10 will provide assistance.
