# Legislative and Communications Update with Chris Assini:

Chris had a meeting with Assemblyman Bronson, a key member who is the Chair of the Labor Committee. Assemblyman Bronson was aware of the pending RRW bills and indicated interest in the legislation. Chris is confident the Assemblyman will sign on as a co-sponsor.

The following have signed on as sponsors of the bill:

Senate: Senators Fernandez, Ramos (Labor Committee Chair), and May

Assembly: Assemblyman Steck, Donald, Gallagher, and Fahey

Chris will continue laying the groundwork in scheduling meetings with meet with other folks to gather up support to get into the budget for next year. Most bills don't go forward in the first year of introduction, so this is to be expected. The response to this initial introduction is promising. Chris also noted that the Senate budget is not as robust as the Assembly budget.

### **Research Update:**

Paul Landsbergis is taking over as lead on the PARSE Research Committee once the transfer from SUNY upstate to SUNY downstate is approved and finalized. Interviews will resume after the transition. Allison shared the list of names for Paul's team to call. Paul asked for volunteers to conduct the interviews. Allison will reach out to prospective survey prospects to participate in the interviews.

# **Funding Opportunities:**

Allison spoke with a staff member in Senator Gillibrand's office. Allison had contacted the Senator's office about sponsoring the next symposium. At the steering committee meeting, Allison shared the document from Senator Gillibrand's office listing who and what they funded and for how much. The grantees tend to be organizations that are not ordinarily funded elsewhere, and these earmarked awards are very generous. Allison feels that this is a good opportunity to get funding for Recovery Ready Workplaces. The application deadline to apply for these earmarked funds is April 5. Chris knows who to contact in Senator Gillibrand's office and will share the contact information with Allison to pursue the opportunity.
